## **NEW BUSINESS**

2021-2022 Board goals were reviewed. Motion was made by Van Den Top, seconded by Remmerde, to approve the 2021-2022 board goals. Motion carried 5-0.

Motion was made by Kelderman, seconded by Rens, to approve RESOLUTION ordering election on the question of continuing to levy a voter approved physical plant and equipment property tax. AYES: Van Maanen, Rens, Kelderman, Remmerde, Van Den Top. NAYS: None. Motion carried 5-0.

Motion was made by Kelderman, seconded by Van Den Top, to approve RESOLUTION approving revenue purpose statement, ordering an election on a revenue purpose statement to authorize expenditures from revenue received from the State Secure and Advanced Vision for Education fund, and ordering the publication of a notice of election. Motion by Kelderman, seconded by Van Den Top, to approve the 2021-2022 IASB Legislative Priorities. Motion carried 5-0.

Discussion was held on the return to learn plan.

Motion was made by Remmerde, seconded by Rens, to allow students/staff the opportunity to attend the Wayne State Honor Band and allow out of state travel for attending. Motion carried 5-0.
