APPROVAL OF AGENDA

Motion was made by Kelderman, seconded by Rens, to approve the agenda with additional items of FFA travel and November ballot information. Motion carried 5-0.

APPROVAL OF MINUTES

CONSENT AGENDA

Motion was made by Kelderman, seconded by Van Den Top, to approve the consent agenda including: invoices and September financial statements. Motion carried 5-0.

NEW BUSINESS

Motion was made by Kelderman, seconded by Rens, to approve request of \$78,522.39 modified supplemental amount for the 2020-2021 negative special education balance. Motion carried 5-0.

Motion was made by Van Den Top, seconded by Rens, to approve the facility lease agreement with Keith Ranschau. Motion carried 5-0.

Motion was made by Rens, seconded by Kelderman, to approve FFA out of state travel. Motion carried 5-0.

SUPERINTENDT REPORT

Superintendent Janzen updated the Board on the HVAC project, bond planning, certified enrollment, and policy review. The November ballot will include renewal of Physical Plant and Equipment Levy (PEL) and the Revenue Purpose Statement. PEL is not a new levy, however, a current levy which requires renewal every 10 years. Renewing our Revenue Purpose Statement will allow us the authority to spend Secure and Advanced Vision for Education (SAVE) funds, which is a current one-cent sales tax school districts use to improve school facilities, technology, and equipment for students.

PRINCIPAL REPORTS

Principal Roder submitted a report on the newly implemented Newcomer program.

Principal De Yager shared information on the Courage Retreat, TAG Program, and implementing staff development items with our students.

Principal Kruger shared information on Fall FAST testing and current elementary events.

Superintendent Janzen and the Board thanked Terry Van Maanen for his dedication in serving the Rock Valley District as School Board Member for 14 years.
