ESSENTIAL JOB FUNCTIONS

- Maintain strict confidentiality while performing position duties in an ethical manner.
- Perform position duties following standard operating procedures of the district, local, state, and federal health/food service regulations.
- Maintain safety regulations at all times.
- Maintain work area in a clean and sanitary manner following approved procedures.
- Assist with the preparation of food and ensure correct quantities are prepared for kitchen and satellite kitchens.
- Set up serving line and scrape table.
- Serve food in a pleasant, neat, efficient, and sanitary manner following correct portion sizes.
- Monitor food temperatures.
- Monitor meal components.
- Prepare food for special diets as required.
- Maintain routine records and prepare routine reports.
- Assists in handling of left-over food appropriately and in accordance with food safety guidelines.
- Assist in maintaining neatness, organization and rotation of stock.
- Maintain daily production records and all applicable required forms for the department.
- Cleans-up kitchen and serving area, includes but not limited to dishes, sweeping and mopping.
- Prepare food, trays, silverware, and equipment for return to food preparation kitchen.
- Work as dish machine operator as needed.
- Participate in general cleaning of kitchen areas, storerooms, and kitchen equipment.
- Knowledge and ability to perform all nutrition positions within the kitchen or work site to which assigned.
- Perform other duties as assigned.
